Overview

This lecture gives an overview of selected theoretical concepts and the main research findings in the field of Comparative Government, specifically focusing on the role of political institutions and their impact on political decision-making at various stages in the political process. The course introduces a number of core themes in the comparative study of political institutions, grouped into three blocks. The first covers electoral institutions and their effects on the behaviour of parties, politicians, and voters. In the second block, we discuss the effects of political institutions on various aspects of legislative behaviour. In the final block, the lecture sheds light on the life cycle of governments and the role institutions play in it.
